

# Become a Vendor at the Robertson County Farmers Market

We're excited by your interest in becoming part of the Robertson County Farmers Market- a welcoming and varied community of farmers, makers, artisans and supporters.

Our Farmers Market is located at 4635 US-41 in Springfield, TN, at the Robertson County Fairgrounds. The Market season runs from May through August..

It is important that you carefully read the guidelines and market rules of the application. It is the goal of the Farmers Market to offer fresh, seasonal produce grown locally by independent farmers. In order to meet this goal, it is vital that our vendors closely follow the Market rules and regulations. The sale of produce and other items from a wholesaler or warehouse is strictly prohibited at the Robertson County Farmers Market.

## **APPLICATION PROCESS**

- Read our Policies and Procedures in full before applying.
- Make sure you have or can obtain the relevant required documents for your application (proof of insurance, kitchen certification, TDA regulatory services permit, organic certification, nursery/greenhouse/plant dealer license, as applicable).
- We greatly encourage you to create a social media account on Facebook and/or Instagram
  and use it to promote your business. Be sure to tag @Robcofarmetsmarket when posting
  items you will have available on Market Day.
- Complete your application and any required documentation to the Robertson County
  Farmers Market via email at <a href="robcofarmersmarket@gmail.com">robcofarmersmarket@gmail.com</a> by the application deadline
  (March 31st), or by sending a paper application and required documentation to the UT
  Extension Office, C/O Robertson County Farmers Market, 408 North Main Street,
  Springfield, TN 37172.
- If your application is accepted, membership fees and market dues are required to be paid 7 days before the opening of the Market. Accepted Vendors must become a Member of the Robertson County Farmers Market Association. Yearly membership dues are \$25 and is separate from the booth fee. Payment for both membership dues and booth fee can be made online through Paypal at <a href="Robcofarmersmarket@gmail.com">Robcofarmersmarket@gmail.com</a> (you will receive an email invoice), by check or cash at the Vendor Meeting, or a check can be mailed to UT Extension Office, C/O Robertson County Farmers Market, 408 North Main Street, Springfield, TN 37172. Please make checks payable to the Robertson County Farmers Market.
- The Robertson County Farmers Market executive committee will review all applications. You will be notified by email of approval and start date.
- If accepted, you must attend the yearly vendor meeting, slated for April before the Market start date. Date will be communicated after acceptance.

# Robertson County Farmers Market Policies and Procedures Updated February 2021

#### **MARKET REGULATIONS**

- The Robertson County Farmers Market consists of three types of Vendors: Farm, Prepared Foods, and Artisan Vendors. All vendors are required to submit an application each year. The Robertson County Farmers Market Executive Team reserves the right to accept or deny applications by any vendor.
- A farm vendor is defined as a person who grows or makes the products they are selling, and may include the producer's immediate family, partners, and employees. Products to be sold must be approved as listed on the application. Products allowed include: Fresh produce & fruits; herbs, flowers, bedding plants, shrubs and trees; eggs, cheese, dairy products; meats and poultry; baked goods, milled products; honey, maple syrup, jams and jellies; mushrooms; juice and cider; soap. Baked goods, farm eggs, cheese, jams, jellies, sauces, cider, breads, and meat must be prepared in legal, licensed, approved and inspected facilities as required by the Tennessee Department of Agriculture or the USDA. Proof of inspection is required. Perishable items must be refrigerated by means of cooler, refrigerated vehicles, etc.
- All products sold at the market must be locally grown/produced in Robertson County, Tennessee.
  - EXEMPTION FOR 2021 SEASON- we are actively looking for dairy (milk, cheese, etc) and egg vendors within a 50 mile radius of Robertson County and encourage vendors with those products to apply.
- All farm products must be grown/produced/made by the farm vendor on his/her owned or leased property. For special exceptions contact the market President/Executive Committee.
- The Robertson County Farmers Market has a zero-tolerance policy concerning resale. Any vendor found selling anything that he/she did not grow or make will be subject to forfeiture of booth space and potentially banned from the market.
- No wholesale brokers will be allowed.
- The Farmers Market executive committee has the right to physically inspect crops and production areas of farm vendors at any time without advance notice.
- It is mandatory that all vendors carry a 1 million dollar liability umbrella insurance policy that names the Robertson County Farmers Market as additionally insured and submit proof of coverage to the market before selling at the market.



#### PREPARED FOOD VENDORS

- All prepared food vendors with annual sales above \$3,000 are required to provide a copy of their business license obtained from the city/county of origin to the Robertson County Farmers Market before selling at the market.
- Prepared foods are permitted for sale at the market. Food products must be packaged with proper labeling and held for sale at the proper temperature and environment.
- Products not listed on the application must be approved by the market before selling.
- It is mandatory that all vendors carry a 1 million dollar liability umbrella insurance policy that names the Robertson County Farmers Market as additionally insured and submit proof of coverage to the market before selling at the market.
- FOOD TRUCKS: Mobile Food Vendors who are approved to sell food (ready to eat or consumed at the
  market) must obtain a Food Truck Permit from the City of Springfield and a Permanent Food Service
  Permit from the Robertson County Department of Health. All food must be prepared and served from a
  mobile food unit as defined by the Department of Health, Food Service Establishment Rule, Chapter
  1200-23-1-02 (12).

#### **ARTISAN VENDORS**

- Local arts and crafts produced by the vendor are permitted for sale at the Market. All applicants please
  include some photographs of your products with your application. A jurying process is required for
  non-farm vendors. Non-farm vendors selection will be made on the basis of quality, originality,
  compatibility with the market's demographics, and market space availability. No franchises or
  independent distributors are allowed. Space is limited.
- All products sold at the market must be locally produced/made in Robertson County, Tennessee.
- All non-farm vendors with annual sales above \$3,000 are required to provide a copy of their business license obtained from the city/county of origin to the Robertson County Farmers Market before selling at the market.
- Examples of handmade and crafted items: weaving, pottery, basket making, woodwork, soap, candles, metalwork, etc.
- Items must be sold by the person who created or made the product, or an immediate family member, or an employee with a very good understanding of how the product was made.



### **GOVERNANCE**

- It is the responsibility of each vendor to abide by all state and federal regulations which govern the sampling, production, labeling, or safety of the product the vendor offers for sale at the Robertson County Farmers Market. Failure to comply may result in forfeiture of the vendor booth space. If the vendors have any questions on this matter, please speak with the President of the Farmers Market the Tennessee Department of Agriculture Consumer and Industry Services. - Most permits and certificates can be found through the TN Department of Agriculture website, https://www.tn.gov/agriculture
- All vendors must complete an application to be considered as a vendor at the Robertson County Farmers Market. The cost for participation is: \$15 per week or \$150 for the season. Refunds will not be given for weeks not attended. Vendors that would like to purchase two booth spaces can do so at an additional charge of \$150 for the season or \$15 per day that is non-refundable. Vendors will need to discuss this with the Market President to check for availability. Accepted Vendors must become a Member of the Robertson County Farmers Market Association. Yearly membership dues are \$25 and is separate from the booth fee. Fees are payable by Paypal (you will receive an email invoice upon acceptance into the Market), by cash or check at the Vendor Meeting, or by mailing payment to the UT Extension Office, C/O Robertson County Farmers Market, 408 North Main Street, Springfield, TN 37172 (return check fees apply) within a 7 days of the opening of the Farmers Market. Please make checks payable to Robertson County Farmers Market.

## Farm products requiring licenses include:

- Eggs: An egg permit is not required. Cartons must be new with the name and contact information of the grower. Eggs must be stored properly and vendors may only sell eggs that are held at 41 degrees Fahrenheit. Eggs used in a booth display are not to be sold to customers, and a sign must be placed at the display reading "For Display Only."
- **Meat:** Must be processed in a USDA certified facility. All meat products offered for sale must have the USDA seal and be stored properly for the entirety of the market.
- **Honey:** Honey processors who produce less than 150 gallons of honey per year are not required to obtain a Regulatory Services Permit. All honey products must be labeled with contact information, net weight and ingredients.
- **Dairy:** All dairy products must come from a licensed dairy or be composed of pasteurized dairy products from a licensed dairy. In addition, such foods must be stored at or below 41 degrees Fahrenheit or frozen at point of sale. No raw milk will be sold for human consumption in Tennessee.



- Plants: Vendors selling rooted plant materials must be inspected and certified by TDA before selling their nursery materials. All rooted plants, berries, and herbs require a license. The exception to this rule is cut flowers. A description of the various applications can be obtained from TDA Consumer and Industry Services. Potential vendors must send a copy of their certificate to the market, as well as keep a copy at his/her booth during each market. - For permits and certificates through the Tennessee Department of Agriculture website, www.state.tn.us/agriculture/regulatory/permits.html
- Food and food products must be packaged with proper labeling.
- Food products must be held for sale at the proper temperature and environment as defined by the food or food product.
- All vendors selling products by weight must have certified scales in accordance with state law.
- Proper labeling pertaining to organically grown produce and meats must be on hand. All products
  listed as organic must be Certified Organic as defined by the USDA National Organic Program. If not
  certified organic, the use of terms such as "naturally raised" or "grown without pesticide" is allowed.
- With the exception of non-potentially hazardous food, all meat, canned food and baked good vendors
  must display a TDA regulatory services current permit and copy of the most recent inspection if
  applicable.
- "Non-potentially hazardous food" means jam, jellies, candy, dried mixes and other such food that do not meet the definition of potentially hazardous food.
- Routine inspections may be conducted. If your product is found unfit to sell at the market, the market
  President/Executive Committee may ask you to discontinue sales of this item immediately. Vendors
  who repeatedly attempt to sell unfit items or produce may be asked to leave the market.



### **MARKET DAY RULES**

- The Robertson County Farmers Market will be open on Saturday from 8:00 am-12:00 pm from May 1-August 28. The market President/Board has the authority to change market hours at any time.
- Fees: \$15 per week or \$150 for SEASON for a 12x10 space. Seasonal fees are due 7 days prior to first set-up date. Those wishing to pay on a weekly basis must pay 1 week prior to their chosen Market Date.
- Space is limited. Vendors who book for the season will take precedence for booth space.
- Vendors must set up in their assigned booth space.
- Vendors must be set up 15 minutes before opening time and all vehicles must be parked away from the
  market area on the fringes of the parking lot. You are not allowed to park near the front entrance of the
  Market.
- Set up time begins at 7:00 AM on Saturday. The Farmers Market is open rain or shine.
- Vendors must provide their own tables, chairs, tent, or other items needed for Market Day.
- Booth space is approximately 12x10. Additional space is available for purchase.
- Booth space may be reserved for all or part of the market season if paid in advance. If vendors who
  have reserved spaces are going to miss a particular market day(s), the vendor must notify the Market
  Manager 24 hours in advance of the market day they will miss.
- Vendors who continually miss the market will forfeit their rights to their booth space. No refunds of
  reservation payments will be made under most circumstances. No subletting of a space is permitted.
  Reserved spaces that are vacated may be rented out to other vendors at the discretion of the Market
  Manager.
- All displays, including umbrellas, tents, canopies and signage must be securely anchored with weights
  and must not extend beyond the limits of the assigned space. Anchors may not be placed in concrete,
  fencing, building, or parking lot.
- Electricity will be provided, but vendors are responsible for bringing their own extension cords.
- All vendors must have their booths clean and empty no later than one hour beyond the closing time.
- Vendors who provide samples and/or products that will result in waste material, such as cups, lids, spoons, etc. must provide containers for waste disposal.
- All food trucks must provide their own separate trash receptacle.
- Vendors must reside in Robertson County. \*2021 EXEMPTION FOR DAIRY AND EGG VENDORS (50 mile radius outside Robertson County).



- Vendors must display a sign indicating their name and address, and any required certificates.
- Sales must be made in an orderly and business-like fashion. Shouting, hawking and other loud and objectionable tactics of solicitation are not allowed. Profanity is not allowed. Loud radios are not allowed.
- No fruit or vegetable products (sold for consumption) can be displayed directly on the ground/concrete.
- Each booth should be kept neat, clean and free from offensive odors. Trash cans will be placed throughout the market facility.
- If using scales, they must be certified by the Tennessee Department of Agriculture.
- Applicable sales tax is the responsibility of the vendor.
- Domestic pets are not allowed inside the market. Service animals are welcome.
- Signs, displays, tables, chairs or shelves cannot remain at the market without prior approval.
- Smoking is not allowed inside the market.
- Alcohol is not allowed on the market property.
- Bikes, skateboards, scooters or other means of recreational transportation are not allowed in the market.
- The market is accessible for the disabled. All vendors should assist in making sure that the space is kept safe and an accessible environment for all customers.
- Complaints must be reported directly to the Robertson County Farmers Market President.
- Enforcement of market guidelines is the sole responsibility of the Robertson County Farmers Market Executive Committee. Any vendor who is found not in compliance with any of the above guidelines will receive a verbal and written warning by the Robertson County Farmers Market Executive Committee. Expulsion from the market will result if the action is not corrected by the vendor.
- All vendors must dress appropriately. Shoes and shirts are required.
- Pricing of goods sold at the market is the sole responsibility of the individual vendor.
- Fraudulent, dishonest, or deceptive merchandising or collusion to set prices among vendors may be grounds for forfeiture of the right to do business of any kind in the market for a length of time to be determined by the market President/Board.
- The sale of live animals is not allowed in the market.



- Soliciting of any kind is not allowed during Market without prior approval of the Robertson County
  Farmers Market Executive Committee. This includes advertising for other events or businesses by
  anyone not associated with the Robertson County Farmers Market and distribution of information or
  product to vendors and/or customers. Please alert the Market President to any problems with persons
  visiting the market to solicit so that we may assess and deal with the situation.
- Inappropriate conduct or language towards other vendors, customers, or management of the market, in person or by electronic media, will not be tolerated and may be grounds for immediate dismissal from the market by the market President/Board.
- Vendors who choose to bring children to the Market are asked to ensure that the conduct of the minors is appropriate and not disruptive to customers or other vendors.
- Vendors are required to inform their workers at the Market of all rules and regulations and make sure they abide by them.

#### **HEALTH & SAFETY**

- Food products must be held for sale at the proper temperature and environment.
- Proper labeling pertaining to organically grown produce and meats must be displayed. All products
  listed as Organic must be Certified Organic as defined by the USDA National Organic Program. If not
  certified organic, the use of terms such as "naturally raised" or "grown without pesticide" is allowed.
- Quality control is one of the most important factors in the Robertson County Farmers Market. Routine
  inspections may be conducted. If your product is found unfit to sell at the Robertson County Farmers
  Market, the Market President may ask you to discontinue sales of this item immediately. Vendors who
  repeatedly attempt to sell unfit items or produce may be asked to leave the Market.

### **Emergency Medical Plan**

- Call 911 with the location of the victim-The Robertson County Farmers Market at the Fairgrounds 4635 Hwy 41N Springfield, Tn.
- Have the person sit or lie where they are and immediately send someone to locate the one of the Farmers Market Executive Committee Members.
- The Executive Committee member will go to the Hwy 41N entrance to direct emergency personnel to the location of the victim.
- Vendors do not need to provide their name or contact information to the person in need (for liability purposes).
- Emergency medical responders will evaluate the victim's condition and determine if they need to be transported to the hospital. The afflicted person will have the right to accept or refuse transport and treatment.



### **Threatening Weather Emergency Plan**

• In the event of threatening weather such as straight line winds, severe thunderstorms, tornados and flooding, vendors will vacate their booth spaces and move immediately to the building adjacent to the market shed.

### **INSURANCE**

• It is mandatory that all market vendors carry a 1 million dollar product liability insurance that names the Robertson County Farmers Market as additionally insured and submit proof of coverage with application before selling at the market.

#### MARKET MANAGEMENT

- The Robertson County Farmers Market is managed by the Executive Committee, elected by the
  Robertson County TN Farmers Market Association members. The mailing address of the Farmers
  Market is the Extension Office, located at UT Extension Office, C/O Robertson County Farmers Market,

- It shall ultimately be the responsibility of each vendor to ensure proper procedures as deemed by the city, state, or federal governments including but not limited to City of Springfield, Robertson County, state of Tennessee, Tennessee Department of Agriculture, USDA, and FDA.
- The Market President's job is to coordinate all the weekly activities and to implement the market policies or delegate duties to another Executive Committee member. The market President also acts as a conduit of information between the vendors, customers, sponsors and community partners. The market President has complete authority to implement policies at the market site.

## **CONFLICT/COMPLAINT RESOLUTION**

- Any vendor or customer with complaints regarding policy or implantation of policy can request a
  meeting with the Robertson County Farmers Market President and will be contacted in a timely manner
  to schedule a meeting.
- Any complaints filed with the Robertson County Farmers Market President/Board about producers not following these rules will be investigated.
- If an infraction of these rules and regulations is noted, an oral warning will be given to the vendor in question. The second warning will be written and the infraction must be corrected by the next market attendance or the vendor will not be allowed to return to the market.
- All complaints will be investigated thoroughly by the market President/Board. If a concern, dispute, or question is noted, the vendor must notify the Robertson County Farmers Market in writing.



- Professional conduct is required during the complaint process. Inappropriate conduct during the complaint process (i.e., yelling, swearing, throwing items, harassing or threatening management, etc.)
   will not be tolerated and could result in immediate dismissal from the market.
- If asked to leave due to misconduct, refunds will not be given.
- All decisions are at the sole discretion of the market President/Board and will be final.

### COMPLIANCE AND INDEMNITY AGREEMENT

As a vendor, wishing to participate in the Market, I (we) agree to SAVE, HOLD HARMLESS, and INDEMNIFY the Robertson County Farmers Market, Robertson County Fair Board, Robertson County Extension Office, and City of Springfield, members, and employees from any and all liability or responsibility pertaining to any damages to person or property on the site assigned to me (us) by the Market, when such damages or liability arise out of acts of my (our) own, or of my (our) employees or associates, located as such site. I (we) verify that all information:

I (we) have provided information about my farm and products for sale is true and accurate.

I (we) understand that the Market operates on limited funds.

I (we) also acknowledge that the Market's beneficial purpose will be impossible to pursue if it is subjected to costly litigation.

Wherefore I (we) hereby agree that as a condition of my participation in the Robertson County Farmers Market, I (we) will resort to litigation against the Market, its agents, officers, management, the City of Springfield will operate, and affiliated entities, only after attempting in good faith to resolve the dispute. I (we) agree to limit any claim I (we) may have as a result of a decision by the Market management or Executive Committee which results in the denial of a market acceptance, the denial of a product to sell, or wrongful suspension or termination from the Market, to a return of market fees incurred during my (our) absence from the Market. I (we) further agree that in the event I (we) am unsuccessful in my (our) litigation against the Market, I (we) will pay all costs, expenses, fees, and disbursements incurred by the Market in the course of its defense of said litigation, and I (we) will also pay the Market attorney's fees.
